



Introduction




With the publication 'Report of Activities 2006-2007 Work Programme 2008-2009' we offer an overall view of the Institute and its strategy.

- Part III highlights the applied research programme of the Institute





Punishment and Recidivism: The Italian Case

UNICRI publication No 88, Turin, 2009

In the Italian judicial system, recidivism of people coming from penal execution is a scarcely known phenomenon. Knowledge of the real nature and size of recidivism appears quite fragmentary, although they are periodically discussed in juridical and political debates. This deficiency is strictly connected with the lack of empirical research concerning the issue.

This work wishes to offer a contribution to the literature on recidivism. It presents results from an empirical research on pardon beneficiaries. The analysis looks at different aspects in recidivist behaviour and questions methodological approaches in criminological studies about recidivism.

Each bibliography is divided into three main categories: *Crime and Crime Prevention* and *Criminal Justice* – reflecting the two broad areas covered by the Institute – and *Miscellaneous*, which in turn are divided into subcategories. For each publication, bibliographical reference is given to title, author, publisher, place and year of publication, and library catalogue number. Each bibliography is followed by two indexes, divided by author and title respectively.



This book argues that an innovative law adopted by the Angolan Judicial System brings to the fore the rights for the protection of minors following years of oversight. It states that this new practice represents a framework for the protection of minors according to international principles.

The first edition of the book, published in 2004, was followed by a second edition in 2008, updated with regulations, international conventions on the right of the child as well as with the additional protocols to the conventions. The Angolan government was supported by the Italian Development Cooperation and by UNICRI for the realization of both editions.


The Fight Against Organised Crime in Serbia: From the Existing Legislation to a Comprehensive Reform Proposal





It presents the causes, consequences and risks of counterfeiting, explains how the distribution chain is entered illegally, and places special focus on the links between counterfeiting and organized crime, and on products that can be harmful to consumers, such as medicines, food and beverages, toys and spare parts for cars and aircrafts.




IPO Security Planning Model






